

## Terms and Conditions

The information provided below in these Terms and Conditions, along with the Cardholder Agreement(s), contain account pricing and terms in effect as of **March 1, 2026**. These account terms may not be available after that date.

If you apply and are approved for a credit card account with us, your actual account terms will be based on the terms of the offer available at the time that you applied, what you are approved for, and your actual Cardholder Agreement will be the agreement sent to you when your account is first opened.

You will lose your grace period on purchases if you do not pay the statement balance (including any transferred or cash advance balances) in full each month, by the payment due date.</p>
<b>Minimum Interest Charge</b>	<p>If you are charged interest, it will be no less than \$0.50.</p>

**How We Will Calculate Your Balance:** We use a method called “daily balance (including new purchases).” These methods are explained in the cardholder agreement.

**Loss of Introductory APR:** We may end your introductory APR and apply the Penalty APR if you make a late payment.

**Military Lending Act:** Covered borrowers under Military Lending Act; Federal law provides important protections to members of the Armed Forces and their dependents relating to extensions of consumer credit. In general, the cost of consumer credit to a member of the Armed Forces and his or her dependent may not exceed an annual percentage rate of 36 percent. This rate must include, as applicable to the credit transaction or account: The costs associated with credit insurance premiums; fees for ancillary products sold in connection with the credit transaction; any application fee charged (other than certain application fees for specified credit transactions or accounts); and any participation fee charged (other than certain participation fees for a credit card account).
